Course description	The course is divided into lectures of frontal teaching, for a total of 6 hours per week, divided into three days. The following program will be addressed.
Course aims and expected learning outcomes	The course aims to examine the general issues of public economic law and the principles that govern the intervention of the State in the economy.
Program (contents, methods of execution) Possible distinction between programs of attending and non-attending students	The Economic Constitution; The economic initiative and nationalizations; Forms and purposes of public action in the economy; Subjects and instruments of public action in the economy; The economic regulation of networked services; Public services; The conformation of markets; The European principle of non-discrimination and the obligations of the public economic operator. <u>Non-attending students</u> are required to observe scrupulously the program indicated in this syllabus. <u>Attending students</u> will have access to a special program, according to the instructions provided by the teacher during the course. It is planned to provide attending students with ad hoc teaching materials during the lessons, and the possibility of taking an intermediate test.

Evaluation methods Oral examination.
