Course description	The Business Law course aims to provide a logical-systematic framework that allows to understand some of the fundamental institutions of the subject and to organize them around a core of general principles.
Course goals and learning objectives (Knowledge and comprehension; ability to apply knowledge and comprehension)	<p>The Business Law course aims to introduce the student to the system of rules that dictates the legal reality and regulates the functioning of entrepreneurial economic activity. Through the analysis of cases that have actually presented themselves to the attention of the courts, critical reasoning and the ability to solve problems thanks to the knowledge acquired will also be stimulated. Upon completion of the course, the student must have acquired a good level of mastery of the technical language of business law and the ability to easily recognize the institutes of which it is composed, applying the current legislation to the various problems that will actually be submitted to him.</p> <p>Knowledge and comprehension.</p> <p>The expected learning outcomes take into account each segment of the training path followed and are pre-established by the degree course of studies, in line with the skills pursued by the prospective student. Each learning area groups teaching modules according to their common objectives. As regards the Legal Area, through the study of the fundamental features of the law the student learns the constitutive elements of national and European legal culture, acquires the ability to read legal texts in relation to diverse contexts of employment; achieves the ability to research and construe the rules, and to apply them to a concrete case. More specifically, the Legal Area develops the following knowledge and comprehension abilities: fundamental notions on the Italian and European constitutional order; notions and fundamental principles of the part of the legal system intended to regulate relations between private individuals; discipline of business activities in its various aspects and forms and in their relations with the market; discipline of the employment relationship; the Italian tax system.</p>

	<p>Ability to apply knowledge and comprehension.</p> <p>Graduates must know how to apply the current legislation to the various cases that will actually be submitted to them, also in relation to highly specialized issues, using techniques and methodologies attentive to a general approach, although never separated from the observation of practice, as well as being able to search and use legal texts applying them to concrete cases.</p>
Program	<p>The program will mainly focus on the discipline of the entrepreneur, competition, distinctive signs, intellectual property, inventions and entities (consortium, consortium company, simple partnership, unlimited partnership, limited partnership, joint stock company, limited liability company, cooperative...) through which the business activity can be carried out collectively, as well as the relationships and events that may affect them from establishment to extinction.</p>
