<b>Course Description</b>	The course aims to provide an overall picture of the conceptual connections between law and social and cultural anthropology. Law can be studied as an anthropological document that reveals a plurality of models rooted in specific cultures evolved over time. Legal norms and institutions are analyzed from a contextual perspective capable of explaining their origin and reason for being and are compared in order to find dominant and subordinate models. The main theories of law are filtered through the fundamental concepts of anthropology to try to understand law as an indispensable product of the human spirit designed for the purposes of survival and social evolution.
<b>Course objectives and expected learning outcomes</b>	The aim of the course is to provide students with a key to understand the fundamental concepts of legal anthropology with particular attention to: diversity of legal models, social evolution, subjective right from a transcultural point of view, natural/unnatural binomial, dynamics of power in the public and private sectors, comparison between East and West; all factors that, in a profound way, determine the structure of legal systems.
<b>Program (contents, methods of development); Possible distinction of programs between attending and non-attending students</b>	The origin of anthropology. The sense of the plurality of rights. The coexistence of many cultures. Legal pluralism. The great epochs of law. The problem of power. The partitions of law: private law and public law. Groups and people. Goods: ownership, possession, contract.  Variations to the program and to the study texts will be agreed with the attending students.
<b>Estimate of the commitment required for</b>	The indicated program requires an individual study of approximately 150 hours.
